Also new in 2023 the ISA has a new President. Richland County Sheriff Andy Hires was sworn in at the December Board Meeting in Springfield, IL. Sheriff Hires was elected Richland County Sheriff in 2006 and is currently serving his fifth term. Sheriff Hires is in his 28th year of Law Enforcement and has served in other positions on the ISA Board since 2015. Let us welcome him into his new role.



**LINK TO THE FULL BILL** 



The Illinois Sheriffs' Association (ISA) is extremely disappointed in the passage and enactment of HB 5471, that further regulates and limits the purchase of a variety of weapons for lawful gun owners.

The ISA has opposed this legislation throughout its development and remains opposed to the bill as passed by the General Assembly and signed by the Governor.

We, as a representative of chief law enforcement officials throughout Illinois, are very concerned and disturbed by the ongoing and escalating violence throughout our State and Country. We are always supportive of new tools, techniques and laws that assist us in preventing and holding accountable those that wage efforts of harm and violence on others.

However, this new law does not do that. We will continue to advocate on behalf Sheriffs and the law-abiding citizens throughout Illinois.

## Here is a summary and bullet point facts from HB5471:

- Assault weapons as defined under this Act possessed by a valid FOID card holder as of the effective date of this Act (1/10/23) may continue to be possessed if registered with ISP.
- Directs ISP to coordinate and develop strategy regarding firearm intelligence and firearm trafficking in Illinois.
- Any person who is not a federally licensed firearm dealer and who desires to transfer or sell a firearm or firearms to any person who is not a federally licensed firearm dealer shall, before selling or transferring the firearms, contact a federal firearm license dealer under paragraph (1) of subsection (a-15) of this Section to conduct the transfer or the Illinois State Police with the transferee's or purchaser's Firearm Owner's Identification Card number to determine the validity of the transferee's or purchaser's Firearm Owner's Identification Card under State and federal law including the National Instant Criminal Background Check System
- The recipient of the weapon shall notify ISP within 10 days of the transfer and retain the record for 20 years, if record held by FFL cost cannot exceed \$25.
- Provides exemption for those that possessed weapons prior to the effective date of the Act and that has provided affirmation to ISP prior to 10/1/23 as prescribed by ISP -this will include make, model and serial number.
- Bans .50 BMG caliber firearms and ammunition.
- Bans the sale and purchase of handgun magazines that hold more than 15 rounds.
- Bans the sale and purchase of long gun magazines that hold more than 10 rounds.
- Bans any device that is designed to increase the rate of fire of any semiautomatic firearm.

## Bans Semiautomatic rifles that have any one of the following:

- Pistol grip or thumbhole stock, any feature that can be held by non-trigger hand, detachable/collapsible stock, flash suppressor, or shroud that partially or completely encircles barrel to prevent nontrigger hand from getting burned.
- Fixed magazine that accepts more than 10 rounds (does not include tubular device for .22 caliber rimfire)

# Bans Semiautomatic pistol that can accept detachable magazine and any of the following:

- Threaded barrel, second pistol grip, shroud that partially or completely encircles barrel to prevent non-trigger hand from getting burned, flash suppressor, buffer tube or other to allow firearm to be fired from shoulder
- Semiautomatic pistol that has fixed magazine that can accept more than 15 rounds
- Any shotgun with a revolving cylinder

## Any semiautomatic shotgun that has one or more of the following:

- Pistol grip or thumbhole stock, magazine with more than 5 rounds, the ability to accept detachable magazine
- Any semiautomatic firearm that can accept a belt ammunition feeding device
- Any part that could convert firearm into assault weapon
- Lists other specified weapons
- · List several excluded items
- Changes the timeline for a Firearms restraining order from 6 months to up to 1 year
- Adds member of the Illinois National Guard that is under 21 to be eligible for FOID card








### **ISA WELCOMES 40 NEW SHERIFFS INTO OFFICE!**




